SAVE MONEY & REDUCE STRESS WITH FREE TAX ASSISTANCE

Does the worry and cost of doing your taxes cause you stress? Free VITA tax assistance runs through the first/second week in April depending on location. Households earning \$79,500 or less are eligible, this year's increase from \$57,000. To find one in your community, visit <https://irs.treasury.gov/freetaxprep>. Ask about completing prior year tax returns. Call now, appointments are limited.

The IRS's Volunteer Income Tax Assistance (VITA) has been in operation for over 50 years, offering free basic tax return preparation to qualified individuals. In 2023, VITA completed more than 9,000 returns, saving clients more than \$2.4 million in preparation fees and securing refunds of more than \$9 million.

Many employees have utilized VITA before. Take for example, Christie Swick (West Michigan ERN), an ERN® success coach since 2012, has seen VITA be such an important service for employees. "The burden of tax filing can sometimes be the tipping point in an employee being overwhelmed with responsibilities," said Christie. "This was the case for one ERN employee who has now used VITA for the last five years. She even started bringing her mother and daughter so the whole family could get assistance."
